WHEREAS, Richard and Laura Czajka have agreed to grant the District an easement interest on the portion of the trail located on their property; and

WHEREAS, Richard and Laura Czajka, in exchange, seek an easement for use of a road located on school property as an access drive; and

WHEREAS, the exchange of interest is permitted in accordance with the terms of the Education Law and appears to be in the best interest of the District.

NOW, THEREFORE, the Board of Education of the Adirondack Central School District resolves as follows:

- 1. The exchange of the subject easements is an Unlisted Action under the provisions of the New York State Environmental Conservation Law and the Board of Education has determined that the exchange of easements will not have an adverse environmental impact.
- 2. The District shall grant an easement interest to Richard and Laura Czajka to use the road on District property which intersects with Schuyler Street in Boonville, New York as an access drive, as depicted in Schedule "A" attached hereto, and in exchange, Richard and Laura Czajka will grant an easement interest to the District for use of the portion of a trail located at 8227 State Route 294, Boonville, New York 13309 by the District's athletic teams, as described in Schedule "A" attached hereto.
- 3. The officers and employees of the District are authorized to take steps to finalize and record all necessary documents.
