

**BOARD OF EDUCATION
ADIRONDACK CENTRAL SCHOOL
MINUTES OF ANNUAL DISTRICT MEETING
TUESDAY, MAY 15, 2018**

At the Annual District Meeting of the qualified voters of the Adirondack Central School District, Oneida County, New York, held at the Adirondack Middle School, in Boonville, New York, in said School District, on the 15th day of May, 2018, at 12:00 o'clock p.m., prevailing time.

District Clerk, Michelle Freeman, reported that prior to the opening of the polls, the voting machine to be used at the meeting had been examined; the counter was at zero and that the machine was, in all respect, in proper condition for use.

At 12:00 o'clock p.m., prevailing time, the Permanent Chairperson, Richard Warren, Esq., announced the voting would proceed. The polls were declared open and all duly qualified voters desiring to vote at any time until 8:00 o'clock p.m., prevailing time, were entitled to cast their vote upon the propositions contained in the Notice of the Annual Meeting. Attached hereto is a sample paper ballot.

At 8:00 o'clock p.m., prevailing time, the Permanent Chairperson, Richard Warren, Esq., announced that all voters in the polling place at or before 8:00 o'clock p.m., having been allowed to vote, the polls were declared closed.
