At 6:00 p.m. Mr. Abdo called the meeting to order.

At 6:00 p.m. Mr. Gallo moved and Mrs. Beasock seconded; carried 5-0; to go into executive session to discuss the proposed acquisition, sale, or lease of real property or the proposed acquisition of securities, or sale or exchange of securities, but only when publicity would substantially affect the value thereof and to discuss the employment history of particular personnel. Mr. Niznik was appointed as Clerk Pro-Tem in the absence of the District Clerk.

Board members returned from executive session at 6:59 p.m. Mr. Muha moved and Mr. Gallo seconded, carried 5-0; to go to regular session.

At 7:03 p.m. Mr. Abdo led the recitation of the pledge of allegiance.

PRESENTATIONS:

Ms. Hoehn and a few of her West Leyden 5th graders gave a presentation on project-based learning. The question presented to her students was "How we can implement a successful recycling program at school". Students visited places and spoke to people throughout the community.

Emma Martin - explained why we need to recycle, how they visited the Solid Waste Authority learning many things about recycling.

- Logan & Michael explained how plastic bags and bottles are important to recycle. "If you see a bag or bottle pick it up otherwise animals can be harmed".
- Darren Sadlowski explained they visited the Ava Landfill and learned how it burns down greenhouse gas to energy. Mrs. Tuttle from the recycling center came and taught them how to recycle even more items. They also assembled a Green Team.
- Rilee O'Hara explained how a worker from the Oneida Co. Waste Authority, Josh, came to school to teach them about how landfills work, what gets thrown into the garbage, what is recycled and how to help others recycle.
