At 6:59 p.m. Mr. Kramer, President, called the meeting to order and led the recitation of the pledge of allegiance

PRESIDENT'S MOMENT:

Mr. Kramer stated what an amazing job done on the Boonville Fire Benefit. There are a lot of generous people in this community.

BUDGET:

Mrs. Cihocki went over Draft 1 of the 2020-2021 Budget discussing the moderate increase in state aid, increase in TRS and health insurance, and how the increase in the number of out of district placements is very costly. The tax levy is needed to balance the budget, should know what the tax cap is at the next meeting.

Mrs. Cihocki talked about the Estimated Debt Service Schedule from Fiscal Advisors showing the district's debt out to 2024. This does not include phase 1 of the existing project or the BOCES project.

She also went over the State Aid Runs which there are a number of unknowns within the projections. Transportation aide needs to be reviewed to determine accuracy, BOCES Aid needs to be verified to see the level of debt for the BOCES capital project and Building Aid does not include the increased aid for Phase 1 of the existing project. The debt also has not been included in Draft 1 of the full budget, those numbers will be included when they are finalized.

FOOTBALL:

Ms. Lauzon, Athletic Director, and Mr. Hennessey, Football coach spoke to the Board regarding 11-man football vs 8man football. A decision has to be submitted to Section III by February 1st. They also talked about having Remsen combine with Adirondack in football. Ms. Lauzon also talked about the game schedule and how Friday nights are limited due to officials. Would like to propose Thursday night games at 6 p.m.

The Board approved Remsen combining with Adirondack football at the varsity level, carried 6-0.

The Board is supportive of whatever coach Hennessey and Ms. Lauzon decide on the 8-man and scheduling Thursday night games.
