MEMBERS EXCUSED:		

At 7:08 p.m. Board President, Mr. Kramer called the meeting to order and led the recitation of the pledge of allegiance.

PRESIDENT'S MOMENT:

Mr. Kramer welcomed anyone participating in our first-time livestream meeting to comply with the stay at home order and social distancing. Thank you to Mrs. Schafer, Mike Adams and Shane Youngs for setting up the livestream.

BUDGET:

Mrs. Cihocki, Business Administrator, discussed Draft 7 of the 2020-2021 Budget. We will be looking at state aid figures in the coming days as the state budget is supposed to be adopted April 1st. This budget has a number of cuts due to declining enrollment, increase in benefits, salaries, increase in TRS/ERS, BOCES, and special ed. placements. Main factor in staff cuts are enrollment driven.

Before giving his budget presentation, Mr. Niznik stated how much students and teachers are missed during this closure. He encouraged parents to reach out to teachers and principals during this time. In the coming days/weeks we will be getting out more information.

BUDGET PRESENTATION:

Mr. Niznik presented a power point of the proposed 2020-2021 Budget which included:

- >> Educational Initiatives STEAM, instructional technology, college level offerings/electives, elementary literacy.

 >> Budget Considerations maintain extracurricular programs, contractual obligations, cost effectiveness /efficiency, academic capacity, decreasing enrollment, revenue and tax impact.

 >> Enrollment Trend showing a steady decline in enrollment over the past few years at Adirondack, just
- like in many school districts.
- >> Projected Enrollment showing projected class sizes/enrollment at Adirondack for the 2020-2021 school year.
- >> Budget reductions include 3 elementary positions, secondary level Science/Music/Technology/Math positions, an administrator, 4 teacher aides, SRO to SPO.
- >> Revenue 2019-2020 school year total \$28,931,250; 2020-2021 school year total \$30,052,380.
- >> Proposed Budget 2019-2020 school year budget total \$28,931,250, 2020-2021 school year budget total \$30,052, 380, increase of 3.3%.
- >> Tax Levy 2019-2020 school year \$9,925,546; 2020-2021 school year \$10,255,016, increase of 3.3%.
- >> Tax Levy History showing tax levy percentages from 2011 2021.
- >> Three Part Budget consists of Program \$21,220,643, Capital \$5,556,038 and Administrative \$3,276,699 for a total budget of \$30,052,380.
- >> Proposition 1 Capital Reserve voters will be voting on this proposition at the vote authorizing the Board of Education to place periodically available funds in a 10-year capital reserve, not to exceed \$10,000,000 to be used for capital improvements as authorized by the voters.
- >> Board of Education Election Two seats available for this election, each seat is for a 3-year term. Terms begin at the Re-Org meeting in July.
- >> Budget vote date TBD due to Governor's Executive Order to postpone.

Mr. Niznik stated there could be additional cuts due to uncertainty of state budget, every day new information comes out. It is important to point out we are not cutting programs.

PUBLIC FORUM:

None due to Governor's Executive Order of no public attendance, meeting livestreamed.
