Resolved that, upon the recommendation of the Superintendent of Schools, the Board of Education accepted the resignation of Mrs. Judy Dustin, AIS Teacher, for the purpose of retirement effective June 27, 2020 (received by the district clerk June 15, 2020). The Board waives the requirement for Mrs. Dustin to provide thirty days' notice prior to the effective date of resignation.

Mr. Niznik thanked Mrs. Dustin for her years of service, she has been here about as long as he has. Wished her many happy years of retirement.

Mrs. Sturtevant moved and Mr. Emery seconded, carried 7-0; the Board of Education approved the following: RPU MOA:

Resolved that, upon the recommendation of the Superintendent of Schools, the Board of Education of the Adirondack Central School District approved the MOA dated June 17, 2020 with the Adirondack Central School Related Professionals Union to address accrued, unused vacation days held by the union's twelve (12) month employees for the 2019-2020 school year.

Mr. Abdo moved and Mr. Muha seconded, carried 7-0; the Board of Education appointed the following Change in Teacher Tenure Area:

Resolved that, upon the recommendation of the Superintendent of Schools, the Board of Education appointed Mrs. Dana Ely, Elementary Teacher, to the position of Special Education Teacher effective September 1, 2020. In addition to an elementary certification, Mrs. Ely also holds certification in special education. She will serve a 3-year probationary period in this new tenure area.

WHEREAS, at the request of the Board, Counsel to the District has prepared an Amendment to the Employment Agreement with such Amendment modifications as further extending the unexpired term of the Agreement and modifying other terms and conditions of employment; and

WHEREAS, the Board and the Superintendent agree to such proposed Amendment.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby accepts and agrees to the Amendment Agreement, dated June 30, 2020, and hereby authorizes the President of the Board, or the Vice President in the absence, to execute said Agreement on behalf of the District and to file same with the District Clerk.

Resolved that, upon the recommendation of the Superintendent of Schools, the Board of Education approved the request of the Adirondack FFA to attend the 2020 National FFA Convention Tuesday, October 26th thru Sunday, November 1, 2020 in Indianapolis, Indiana. Transportation will be needed to drop off and pick up FFA members at a location to be determined when final arrangements are made. This approval is contingent on COVID-19 developments and all trip deposits will be fully refunded if canceled.
