PRESIDENT'S MOMENT:

Mr. Kramer announced Mr. Niznik had something come up that he needed to attend to and would not be at the meeting this evening, meeting would go on as usual.

Mr. Kramer mentioned it is a busy night at Adirondack. The football team is playing out on the turf and the swim team is at Holland Patent. The girls' soccer team won against Waterville. It is good to see sports going on and good to see people enjoying them.

PUBLIC FORUM:

No one came forward for public forum.

ADMINISTRATORS' REPORTS:

Mrs. Smith – High School Principal:

- Thank you to the Board for taking tour of the building.
- HS mad a celebration of students coming back in person. 294 students are in person, 53 are 100% remote.
- Thank you to teachers and staff for all they have done.
- 86 students have raised one failing grade to passing.
- 28 HS students have taken the SATs.

Ms. Rowlands-Will – Middle School Principal:

- MS is excited to have 264 students back in person, 28 students are 100% remote.
- 77 MS students have taken advantage of extra help.
- On April 21st MS students will be participating in computer-based testing for the first time.

Mrs. Schafer – BE Principal:

- Both West Leyden/Boonville Elem held bike safety assemblies for kindergarten students. Each student received a new bike helmet donated by the Boonville Elks Club. A big thank you to them.
- Required fire drills and lockdowns are being practiced with the nice weather.

- Boonville Elementary's goal for PARP was to read 150,000 minutes, students read 175,000 so as promised Mrs. Schafer is getting slimed. Top readers will be announced. So proud of students/parents.
- 378 students have returned for in person learning, 24 students are 100% remote.

Ms. Weber – WL Elementary Principal:

- Both elementary PARP participations were very successful.
- West Leyden's PARP goal was to read for 10,000 minutes, students read for 11,000 minutes so West Leyden has a new school hamster. A naming contest is being held to come up with a name.
- Simulation for computer-based testing in grades 3-5 has been completed.
- Coming up on the end of the 3rd marking period we will take a special look at student success and students who need support.

Mrs. Foye – Director of Special Education:

- Busy this month with meetings, 51 CSE and 4 CPSE.
- Working to make sure students are ready for state assessments that are coming up.
- Finalizing applications for extended school year services.

Mrs. McGrath – Director of Technology, Curriculum and Instruction:

- Working on a tech grant with Mrs. Cihocki called the Learning Technology Grant due 10th, maximum amount \$100,000, looking at Chromebooks, STEAM equipment, professional development and implementation of digital literacy and computer science standards.
- Exploring possibility of a school-based health center to include a dentist for the district like most schools in the North Country have. This research is in the early stages.

Mr. Maneen – Transportation Supervisor:

- Happy to see students back in person.
- Number of students on the buses fluctuates average of 400 students riding buses. Using all buses and drivers.
- Mandatory 2-hour refresher coming up.
- Looking at and doing research on the use of electric buses.

Mr. Teachout – Director of Facilities III:

- Custodial staff spent the past month installing dividers, returning furniture to classrooms, cleaned out a lot of broken, outdated items.
- Fields have been prepared, bathrooms open. New batting cage at Boonville Elem.
- Spring cleanup outside, raking lawns. Parking lots will be swept of sand from sanding over the winter.
- Facilities committee met. Do have surplus money from alternates. Talked about process of what can be done, looking at a Phase III, and looking at getting tanks out of ground.
- 100K project looking at transportation.

Mr. Roberts – Asst. HS Principal/Interim AD:
