- Electric Bus Vote Re-Cap Mr. Brach stated this was a hot topic at the Board Convention. Superintendent McGrath stated she has seen/heard that local politicians are getting involved writing letters to the governor.
- Total Solar Eclipse April 8, 2024 Early Dismissal since it is going to occur at 3:23 p.m. This is a once in a lifetime experience. Schools and communities are planning activities, hotels are already booked. In the Buffalo area they are closing schools for that day. Superintendent McGrath is looking at an early dismissal and hold activities with students leading up to that day. Insurance is saying children need to be monitored to wear the sunglasses, could be a liability. Maybe have parents sign permission slips.
- Dual sports participation continued discussion from public forum There is question of conflicted events, how to do 2 practices, how do coaches feel about this, are certain sports compatible, some are not.
